

STUDENT/PARENT POLICY ADDENDUM - Adherence to Stay At Home 2.0 Guidelines

I am aware that my actions as a parent or guardian may also impact the safety of others in the Atlantic Gymnastics facility. By entering the building, I agree to comply with the following procedures and expectations. Please initial after reviewing each policy listed.

Drop off/pick up of students is encouraged. All customers will follow the traffic pattern for entrance and exit that we establish. No loitering in the building before and after class times. _____

Face coverings over nose and mouth must be worn when in the facility and not engaged in a workout. _____

While parents/guardians are always able to watch, Atlantic Gymnastics will limit in-person viewing to no more than one adult per student in the building. While in the facility guests agree to comply with NH state guidelines which currently require practicing spatial distancing of a minimum of 6 feet or more throughout the facility at all times. Physical distancing will be practiced upon entering and leaving the gym assisted, if necessary, by Atlantic Gymnastics staff. _____

While physical distancing restrictions remain in place Atlantic Gymnastics will not have any seating in the first floor lobby or upstairs observation room. (PORTSMOUTH GYM ONLY) _____

Students will do their best to keep a 6 foot distance from their teammates/classmates and coaches/teachers when feasible. _____

Drinking fountains will be closed. Water bottle refill stations will remain available for use with personal water bottles. _____

Students will **wash hands at a minimum before and after each class**. Everyone entering the building will be required to wash/sanitize hands. Hand sanitizer will be provided throughout the gym and in the lobby. _____

Those who have been in close contact with a confirmed or suspected case of COVID-19 in the past 14 days, are experiencing a cough, shortness of breath, or sore throat, or have had a fever of 100.4 degrees F or higher within the last 72 hours agree to not enter our facility but to come back when feeling better. Students will tell coaches immediately when/if they are not feeling well. _____

Customers/students who have travelled within the last 14 days, internationally, by cruise ship or **outside** of NH, VT, or ME **on public transportation** (e.g., bus, train, plane, etc) will not enter the premises. _____

No tuition refunds or credits will be provided for missed classes. ***There are no makeups, credits or refunds offered for missed or cancelled classes due to forced closures.*** _____
